\*Our units are all NON-SMOKING. A fine of \$250.00 will apply for smoking in units.

\*When wristbands are issued, replacement of wristbands at an extra charge of \$25.00.

\*The use of grills are not allowed on the balconies or in the property. A fine of \$1,500 will apply.

\*Unregistered visitors will not be allowed in the property. A fine of \$60.00 will be applied per person.

\*By law, Handicap area is restricted. Vehicles will be towed away at the owner's expense and each car is subject to fines by law enforcement (typically \$585 USD).

\*NO PETS ALLOWED ON PROPERTY OR IN ROOMS. A fine of \$500.00 will apply. Guests concealing pets will be subjected to immediate eviction.

\*As per State Law, no outside alcohol is allowed on Pool Decks or Restaurant Patio as it has been designated as a TABC "Red Zone". Violators may be subject to prosecution. Additionally, no outside food or beverages are allowed in public areas, as per hotel policy.

\*Items for sale in the hotel room and consumed by guests will be charged once inventoried by hotel staff, and may be done several days after departure, once room is assessed.

\*No glass or ceramic is allowed on the pool deck or patio areas. A fine of up to \$250 per glass/ceramic item may be assessed per city ordinance.

\*Children under the age of 18 are not allowed in hot tubs, without exception.
